Welcome to visa services, these services allow the user to issue, cancel, Extend exit Re-Entry and Final exit for his Sponsoree and his non Saudi Family members. To issue and cancel visa for non-domestic Sponsorees, use the visa services in Absher Business.

The following business rules should be observed before applying for visa:

Issuing Final Exit Visa:

- Sponsor and Sponsoree status should not be dead, reported as absent or has Istigdam violation.
- All traffic violations against sponsoree must be paid.
- Sponsor or Sponsoree does not have any Earlier issued Visa Cancelation penalty
- Sponsoree should not have (Previous) Valid Visas
- Sponsoree should be present in the Kingdom at the time of issuance of Final Exit Visa
- Sponsoree Passport validity must be equal or more than 60 days
- Sponsoree Igama should be valid
- Finger print Enrolment status for all Male/female sponsorees/family members above the age of 6 years should be present.
- The sponsoree must not have any registered vehicle in MOI system

Final Exit Visa cancelation:

- Sponsor and Sponsoree status should not be dead, reported as absent or has Istiqdam violation.
- Sponsor or sponsoree should not have earlier issued Visa Cancelation penalty.
- Visa should be valid & Cancelation should be within 60 days from issuance date in case it is not used, otherwise penalties will be applied
- Sponsoree should be present in the Kingdom

Issuing Exit Re-Entry Visa:

- Sponsor and Sponsoree status should not be dead, reported as absent or has Istigdam violation
- All traffic violations against sponsoree must be paid.
- Sponsor or Sponsoree does not have any Earlier issued Visa Cancelation penalty
- Sponsoree has no (Previous) Valid Visas

- Sponsoree should be present in the Kingdom at the time of issuance of ER Visa
- Sponsoree Passport Validity should be equal or greater than 90 days
- Return before date can be same or less than the Igama expiry date
- Igama validity should be equal or greater than (Visa duration +90 days) for "duration in days option"
- In case of "Return date option" the selected date is the last date of return to Saudi Arabia.
- Gregorian date will be considered if there is a difference with Hijri Date.
- Finger print Enrollment status should be present for all Male and Female Sponsorees above the age of 6
- Payment of visa fee
- If you intend to visit any of the Gulf countries; please note that your Iqama ID must be valid for 3 months from the date of Visit/entry into the gulf country.
- In case of exit-reentry visa expiry, the sponsor or employer can extend it through the Ministry of Foreign Affairs website.

Exit Re-Entry Visa cancelation:

- Sponsor and Sponsoree status should not be dead, reported as absent , has Istiqdam, violation
- Sponsor or sponsoree should not have any earlier issued Visa Cancelation penalty.
- Visa should be valid & cancelation should be within 90 days from issuance date or before return date whichever comes first, otherwise penalties will be applied
- Sponsoree should be present in the Kingdom

Extend Exit Re-Entry Visa for sponsorees outside kingdom:

- 1. Sponsor and Beneficiary status should not be dead, reported as absent or has Istigdam violation
- 2. Beneficiary should NOT be present in the Kingdom at the time of Extension of ER Visa
- 3. Return before date should be 7 days less than Iqama Expiry date.
- 4. Igama validity should be equal or greater than (Visa duration +90 days) for "duration in days option for Single ER Visa"
- 5. In case of "Return date option" the selected date is the last date of return to Saudi Arabia.
- 6. Gregorian date will be considered if there is a difference with Hijri Date.
- 7. Payment of extended visa fee
- 8. Visa cannot be extended for more than 180 days.
